Notice is hereby given that on July 30, 2012, the director of Ohio EPA issued a final renewal Hazardous Waste Facility Installation and Operation Permit (Permit) to The Lubrizol Corporation (Lubrizol) for its facility located at 29400 Lakeland Blvd., Wickliffe, Ohio. The Ohio EPA Identification Number for this facility is OHD004172565. Lubrizol is engaged in the research, development, and testing of lubricant additives, fuel additives, and other specialty chemicals. These activities result in the generation of a variety of hazardous wastes. The renewal permit authorizes Lubrizol to treat and store hazardous waste in containers and tanks. To issue this final Permit, Ohio EPA determined that the Permit application is complete and meets appropriate standards and that the applicant has a history of compliance with relevant environmental laws.
