Kron Water Reclamation Facility, at which time bids will be opened and read publicly and thereafter awarded or rejected within sixty (60) days.

Bids must be accompanied by a bid bond or certified check in the amount of five percent (5%) of the bid amount, drawn on a solvent bank and made payable to the Treasurer of Lake County.

The Board of Lake County Commissioners reserves the right to reject any or all bids, to waive any informalities or irregularities in the bids received, and to accept any bid which it deems to be in the best interest of Lake County. No bidder shall be considered a responsive and responsible bidder or eligible to be awarded the contract to which this Notice or Bid specifications apply, if the bidder is listed on the Auditor of State's Database as having an unresolved "Finding of Recovery" as that term is defined in R.C.9.24. The contract will be awarded to the lowest and best bidder.
