Matt Battiato, Job and Family Services Director: This is a negotiation of a 2 ½% increase with our bargaining unit for one year to be effective July 1, 2102. We receive federal and state allocations beginning July 1<sup>st</sup> and we were able to determine that we are in a position to provide increases. None of this funding would come from the County General Fund. The department has been consistently losing employees to the private sector. We have not been able to be competitive in terms of attracting employees who could manage these unique responsibilities in terms of determining eligibility for public assistance, child support enforcement, and child protective services. This does not affect our non-bargaining employees, they have not had an increase coming up on four years. I hope some time in the future that this can be addressed.

Commissioner Aufuldish: The stress that these folks are under is pretty intensive.

Mr. Battiato: Correct. The past three to four years is probably the highest volume that we have ever seen in terms of persons applying for public assistance programs because of losing their jobs or being laid off possibly for the first time in their lives.

Commissioner Troy: This is the final year of a three year contract that was negotiated in 2010 and there was a wage re-opener provision. Next year, negotiations will start again for a new contract to begin on July 1, 2013. This is this bargaining unit's first raise in three years and it will be at 2 ½%. It is a negotiated rate and is part of collective bargaining. Week in and week out we are continually filling vacancies in Job and Family Services due to turnover; the amount of employees has not grown. This same number of employees is handling a lot heavier workload. The indication is that this is probably reasonable at this time. At the same time, we like to keep as even a playing field as possible between all of the employees regardless of what funds they are being paid out of.

Commissioner Sines: Yes, this is a unique situation where we negotiate the contracts for these groups and the state just says okay we will pay it. I believe it should be the state, rather than the county in these negotiations. As Commissioner Troy said, we have strived in the past years to have job positions pay the same whether you work in Job and Family Services or the Utilities Department, which follows a trend that is good for the employees. I think it is a contract that needed to be signed.

Commissioner Troy: There have been discussions as to why the state doesn't run these offices since it is their program, their rules, and their money. Instead the responsibility is imposed on county governments.

Mr. Battiato: That conversation always seems to be present, but we are state administered, county run and are one of the few in the United States that are set up this way.

Commissioner Aufuldish: This is one of the many plus services that your department offers that goes underneath of radar and not too many folks realize that we are keeping these people working and off of unemployment and public assistance.

Mr. Battiato: These are federal dollars that come to the county funded through the Workforce Investment Act.

Commissioner Troy: This resolution will create an advisory panel. We have had an unofficial group called the Senior Citizens Levy Coalition, which is made up of representatives of the senior centers, Council on Aging and R.S.V.P. The voters just approved a renewal of an additional tenth of a mill on the Lake County Senior Services Citizens Levy. That levy is placed before the voters by the Commissioners and the Commissioners are responsible for distribution of those levy proceeds. The creation of this five member panel appointed by the Commissioners will be responsible for making recommendations as to what the needs are for the various groups such as Council on Aging, R.S.V.P., senior centers, and any other program that may be worthy of receiving these appropriations. This makes sense because it is the Commissioners' fiscal responsibility to manage these levy funds. This will allow for changing and fluctuating circumstances and needs from year to year. I feel that this will be a wiser and sounder method with this group. We will be looking at individuals that may be interested in serving on this panel. It is an unpaid position, which will probably have to meet only three to four times per year.

Commissioner Aufuldish: We have received a legal opinion though Prosecutor Coulson recommending that the Board of Lake County Commissioners pass a resolution in order to establish a Senior Citizen Advisory Panel that will assist them in fulfilling their statutory duty to distribute levy funds for the benefit of seniors.

Commissioner Sines: The needs assistance for the senior population is changing all of the time. I think its necessary to look at a different perspective on whether the way we fund these programs needs to be changed. For example, the majority of the dollars in the senior levy goes to the senior centers and maybe that is not getting to the real senior needs. With this panel we will get a wide assessment of the senior needs in the county and their needs for the future. I believe the taxpayers who have supported this levy will be happy to see that we are looking at other ways as to how these needs should be met.

22. RESOLUTION APPOINTING JASON W. BOYD TO THE POSITION OF COUNTY ADMINISTRATOR FOR THE LAKE COUNTY COMMISSIONERS' OFFICE, EFFECTIVE AUGUST 6, 2012 (20120628\C04) (P-105)

Commissioner Sines: It has been awhile since we have had a County Administrator. Jason continues to handle all of his responsibilities over the last several years from the Planning Commission, CDBG Programs and all the things that we have thrown at him with a great deal of style, expertise and knowledge. Bill Margalis has done a great job taking care of human resources, insurance and administrative responsibilities. Government is changing and it has gotten to be a more complicated job for just one person. Jason's background is planning. He is young, aggressive, talented, and the type of vision that we need in Lake County to meet the challenges of the future. This is a great move for the county, and I believe that we will be very well served with Jason as the new administrator.

Commissioner Troy: We are doing this to enhance and improve our governing structure and Jason will assume his new duties on August 6, 2012 by virtue of this resolution. The Ohio Revised Code authorizes Boards of County Commissioners to appoint a County Administrator. This job description is somewhat redefined than what we have had for county administrator in the past; for example, he will be very involved in compiling the annual budget. The budget is the most important document that any governmental entity deals with because it sets the policy and priorities in the county. With Jason's experience as Planning Director we feel he can foster better relationships with our partners in local governments. He has worked especially close with the Lake County Port Authority, which is the economic development department for Lake County. Jason has been with the county since 2000. He is a recognized talent, and there have been a lot of people that have been after Jason to come work for them. We have a very valuable asset under the county's employ here and we want to utilize those talents to the greatest degree. And, putting him in this overall County Administrator position demonstrates that. The Lake County Planning Commission is a separate entity under state law. That office will be restructured as the new county Department of Planning and Community Development. It will be designed and encouraged to work with the Lake County Port Authority on development and redevelopment issues under the supervision of Mr. Boyd. Current Chief Planner David Radachy will serve as head of this new department. The current eleven member Planning Commission will continue to exist and periodically meet and function in its statutory role of subdivision review and approval, and its statutory role to advise townships on proposed zoning text changes. The members of the Planning Commission are not compensated for their position, and are appointed by the Board of County Commissioners. The new county Department of Planning and Community Development will provide administrative support as needed to the Planning Commission to assist in the performance of these duties. We are keeping the planning concept, but marrying that with community development and redevelopment. Jason enjoys respect throughout the communities in Lake County and certainly we want to take full advantage of his talents and abilities. Thank you for accepting!

Commissioner Aufuldish: One of the key items that I think Jason will be able to help us with is our strategic planning. As Commissioner Troy said, this is the second department that we are combining as we continue to slowly shrink county government. Jason will also be looking at the possibilities of consolidating opportunities for other departments. Jason will be our information officer for releases to the press. I thank Jason for accepting this offer.

Commissioner Sines: Someone will say this is a new hire and we are spending more money than we are budgeted. This will not affect the budget of the Commissioners Office because of the way Jason will be paid with the different departments that he will be directing and working with. We are holding the line in spending. We thank you for accepting this position Jason. Moving forward, I believe this will be a benefit to all of the departments in the county.

Jason Boyd: I want to thank the Commissioners for this opportunity. Back in 1999, I was in Athens, Ohio finishing up my graduates degree. In July 2000, I started with the Planning Commission and I have enjoyed every minute of it. I want to thank the current staff of the Planning Commission and Board Members. They have been really good to me and have taught me a lot personally and professionally. With CDBG being allocated to our office in the past few years, I have gotten to meet a lot of other department heads. I feel like I have a good relationship with the county, and I feel like I have a really good relationship with the communities. My top priority is to continue this positive dialogue and I am really excited to get started.
