- Allegheny County has changed their form of government to a county executive with an 11 member council.

- A concern is that not a lot is going to take place in Washington D.C. between now and November. Because the Super Committee did not reach an agreement; there will be automatic funding cuts under what's called sequestration in 2013. These automatic cuts in government spending could seriously affect CDBG funds and funds that flow into our courts. - NACO was pleased that Congress finally adopted a highway transit bill, even though it's only good for two years. That affords a little stability in terms of projects that have an inclusion of federal funds.

- One of NACO's 11 major steering committee's is Finance and Intergovernmental Affairs. Commissioner Troy has been asked to continue as chairman of that committee.

PUBLIC COMMENT: John Muzik, Painesville Township briefly discussed with the Commissioners distribution of the money to be received in the counties from casino proceeds.

Amy Elszasz, Clerk: Just a reminder that at 11 am there will be a CDBG and HOME Program Public Hearing for the proposed use of 2012 funds.
