Solid Waste Facility Hours Continue To Be Extended

Kirtland, OH – In response to the ongoing cleanup efforts taking place in Lake County communities that experienced severe flooding this past Saturday July 20th, the Board of Lake County Commissioners are continuing to extend the hours of operation at the Lake County Solid Waste Facility. Because of the large response from residents, and the need for additional hours, the county commissioners have agreed to extend the hours of operation into the week of July 29th.

In addition, the collection this Saturday, July 27th, is now open to private haulers and public works departments for community **flood related items only**.

Saturday's (July 27th) hours are:

9:00 a.m. – 4:00 p.m. (residents, including cars & pickup trucks)

9:00 a.m. – 3:00 p.m. (private haulers, large trucks & public works depts.)

The following will be the hours of operation at the Lake County Solid Waste Facility for the week of July 29th:

July 29th thru August 2nd: 7:00 a.m. – 7:00 p.m. (residents, including cars & pickup trucks)

7:00 a.m. – 5:00 p.m. (private haulers, large trucks & public works depts.)

The collection activities are for community flood damage related items only.

ALL VEHICLES MUST BE TARPED

The Lake County Solid Waste Facility will not accept the following:

Demolition

Hazardous Waste: paint, paint products, chemical sprays, pesticides, batteries, automotive fluids, household cleaners, used motor oil;

Liquid Waste: paints, chemicals, solvents, automotive fluids, used motor oil;

Yard Waste: brush, tree branches, stumps, grass leaves, fire wood, weeds, bushes.

The Lake County Solid Waste Facility is located at the junction of State Route 2 and U.S. Route 20 (North Ridge Road) at 2039 Blasé-Nemeth Road in Painesville Township.

Additionally, the Lake County Emergency Management Agency (EMA) understands there is still a number of elderly and handicap residents that may need help with storm damage cleanup. The need for additional assistance is currently being evaluated, and volunteer organizations that participate in the cleanup efforts are being contacted. At this time, elderly or handicap residents are being asked to call the "211 Information Line" to make officials aware of your need for cleanup assistance. Residents who call 211 will be put on a list, and clean up assistance may be scheduled for the week of July 29th. Cleanup response is dependent on the availability of volunteer organizations.
