FINANCE: Mike Matas, Director: The sales tax revenue is up approximately \$40,000, which is similar to last month. For the year we budgeted at a 3% decrease from last year, and right now we are sitting at -3.02%.

Commissioner Troy: This reflects activity from March and April in Lake County, which are a up slight amount of what was collected during the same period of 2009. However, that period in 2009 was substantially lower than what was collected in 2007 - 2008.

CLERK: None

- Brief discussion took place regarding a Painesville Township vacation request under review.

LEGAL: Pat Nocero, Legal Counsel reminded Commissioner Troy that he has an appointment at 3pm at the Court of Common Pleas.

OLD BUSINESS: There was no old business.

NEW BUSINESS: Commissioner Troy: I am pleased to announce that the Lake County's Workforce Investment Board has been named the 2009 Workforce Investment of the year for the State of Ohio. Congratulations to Mr. Bob Dawson and all the folks we appointed from the business and labor community that sit on that board. This board works on retraining folks and tries to place them in jobs, which has been very difficult. Certainly we are not where we would like to be in terms of employment in this county, but the State of Ohio has given us a big "A" for effort.

Commissioner Sines: Bob does a great job, and obviously we have a great board with some innovative ideas. We are fortunate!

PUBLIC COMMENT: Frank Cotturo of Leroy Township requested an explanation regarding the process for the Sheriff to put a levy on the ballot for additional law enforcement service in the townships.

Commissioner Troy briefly explained that placing this levy request on the ballot is between the township's trustees, and their citizens. The contractual relationship would be between the individual Boards of Township Trustees and the Sheriff of Lake County. - Brief discussion from Commissioner Troy and Commissioner Aufuldish that an article in today's News Herald is not a factual statement in stating that the Sheriff's budget has been reduced for each of the last five years. Only beginning in 2009 did that budget get squeezed a little bit because of the economy along with every other budget in this county.

Commissioner Sines briefly discussed that the Sheriff's budget this year is less than his 2005 budget. And, realistically we are looking at anywhere between a 6%-10% cut in our budget next year. The Sheriff is taking a proactive look knowing that there will be cuts.

Commissioner Troy: By resolution, we have moved the Commissioners' Meeting next week from Thursday to Wednesday, August 4, 2010 at 10 am.
