10. RESOLUTION ESTABLISHING THE LAKE COUNTY EMPLOYEES' SHARE OF THE MONTHLY PREMIUM FOR MEDICAL AND DENTAL INSURANCE COVERAGE, EFFECTIVE JANUARY 1, 2012 THROUGH DECEMBER 31, 2012 TO REFLECT A CHANGE IN THE MONTHLY PREMIUM (20111103\C02) (INS)

Bill Margalis, Administrative Director: This resolution is one that we pass every year setting the rates for the upcoming year. These rates will be effective for our county employees on January 1, 2012 and are a result of our negotiation process. Every three years, we request proposals and have made the decision to switch carriers this year. We have been with UnitedHealthcare for 10 years and will now go with Anthem. Being self-insured, we pay an administrative fee to manage and pay the bills of our medical expenses. We will use the discounts that Anthem has negotiated with the various hospitals and providers where a considerable amount of money will be saved for 2012. These rates reflect a 10% increase in our healthcare costs over last year. The employees portion in the past were anywhere from 7.5% - 8% and now will reflect an increase of 11.5% - 12%.

Commissioner Afuldish: I would like to thank Bill for all his hard work in these negotiations. I feel despite the fact that we had to increase the employees' portion that this is still a very, very fine program health wise. Anthem has increased our wellness funds to \$50,000 annually, which is currently \$25,000. If an employee participates in the Wellness Program, a family premium will cost \$188 versus \$200, which is a savings of \$12 per month. We are very pleased with these negotiation results.

Commissioner Troy: It is unfortunate that we do have to raise the employees portion of the health insurance premiums, which is the primary benefit that most receive on top of their salaries. The cost of insurance has gone up 10% from this year to last year. The overall premium that the county will be paying will go up considerably more than the individual employee contribution. The highest priced plan to include health, dental, prescription, etc... for a family of three or more will go up to \$60 more per month to about \$200 a month, and the county's portion will be \$1,600. I know that the employees have not seen raises for a while, but the value of health insurance is critical for them and their families. The co-pays and deductibles have not been changed. We had a good experience with UnitedHealthcare, but we are going with Anthem who offered the best numbers. We certainly appreciate the fact that our employees continue to serve the public during these trying times. I think that the fact that we are self-

insured has really kept our rates down.

Commissioner Sines: We have been with the same carrier for 10 years, and obviously it is always a little bit uncomfortable to make a change. But, in this environment we continue to look at the rates and continue to look at saving every dollar that we can, which the difference between carriers is \$500,000. If we stayed with the same carrier we would have to look at higher premiums that the employee would have to pay. We have been at 7%-8% and now we are at 12%. To the average person a 12% cost is a pretty good deal. There are other governmental agencies who pay 100% of the healthcare. And, the average person working for a private employer or self-employed are paying 25%-50% of premiums, and paying co-pays and deductibles. We try to make the best decisions for the county and our employees and hopefully the efforts are appreciated. Even with this increase, it is still a pretty good deal for the employees. Employees will get the same care and can use the same doctors.

Commissioner Sines: Willoughby Hills asked if their residents could tap into some CDBG Funds for folks that can't afford to pay the fee and installation. They are Lake County residents and it just makes sense.

OLD BUSINESS: There was no old business.

NEW BUSINESS:

- Commissioner Troy briefly discussed a letter from the National Association of Counties(NACO) asking the Commissioners to send a letter of repeal to our senators regarding the 3% withholding provision that has now been delayed until January 1, 2013. Otherwise it will require us to withhold 3% of all contracts over a certain amount, thus basically acting as a tax collector for the IRS.

- Commissioner Troy briefly discussed with Mr. O'Donnell of the Prosecutor's Office a letter from Cathy Walsh of the Community Improvement Corporation (CIC) who advises that all CIC originated loans have been reconciled and are no longer active and inquired if it is time to disband this entity and transfer these funds to the Lake County Port Authority.

- Commissioner Troy briefly discussed at the recent Mayors and Managers Meeting that there are a number of communities that contract with Lake County for building inspection services. No money is made on building inspections and the department is always struggling to make sure it isn't being subsidized with the general fund. Lake County would be interested in serious discussion with the communities about centralizing building inspection as much as possible. There is some strong interest from Painesville City and Eastlake.

Commissioner Sines: You are right, building inspection is a break even operation and if we can help out in these communities it makes sense.
