RESOLUTION SUPPORTING THE LAKE COUNTY DEPARTMENT OF JOB AND FAMILY SERVICES' WORK PARTICIPATION CORRECTIVE COMPLIANCE PLAN AND CERTIFYING THE COUNTY COMMISSIONERS' COMMITMENT TO CORRECTING LAKE COUNTY'S NONCOMPLIANCE WITH 45 CFR 261.21 AND 261.23 IN FEDERAL FISCAL YEAR (FFY) 2012 (20111110\JFS01) (JFS-11)

Bob Dawson, Job and Family Services Division Administrator: The State has written a new plan and it is being pushed down to the counties due to 87 out of the 88 counties being out of compliance. This plan will address the new state rule changes and procedures. The biggest rule change is eligibility for public assistance where an individual will be required to participate in a two week, good-faith job search before their benefits are activated. Job search and education will be documented and supervised.

Commissioner Troy: I would like to point out it was the Ohio Department of Jobs and Family Services that was found not in compliance by the Federal Government and the 87 counties follow the rules at the state level. This resolution indicates that this Board of County Commissioners is in support of Lake County Job and Family Services proposed plan and commitment to compliance.

Bob Dawson: This resolution will provide transportation to individuals during the two week good-faith job search. During this period, an individual is eligible for 20 Laketran tokens or a \$25 gas allowance towards job searching. This is a shift of TANF funds and is not additional monies.

Commissioner Aufuldish: This is for Eastlake, Wickliffe, Leroy Township, Laketran, Fairport, N. Perry, and the Health District who participate in the county plan.

Bill Margalis, Administrative Director: This will set the rates for the 12 sub-entities that the county has under our health plan and reflects a 10% increase. Each community has a different rate assigned based on their underwriting.

Commissioner Sines: We offer this plan to communities and governmental agencies within the county

and it has worked well for all involved.

Commissioner Troy: These are three-year agreements subject to review in order to protect the interest of the county. The county is self-insured and is not in this to make or lose money.

Dan Donaldson, Soil and Water District: This is an annual event at the end of the construction season. It is critically important to get sites stabilized for winter. There is one site that is not in compliance and I imagine this will be resolved quickly as soon as they receive notice.

Commissioner Troy: This resolution is asking the Prosecutor's Office to initiate enforcement procedures to drive compliance and protect the general public.

Chad Edgar, Soil and Water District: The violation includes a permanent seeding of the lawn and is not a wetness issue. Commissioner Aufuldish: The individual has been sent three different letters and has not complied.

Jason Boyd, Federal Grants Administrator: This is an agreement with Western Reserve via a pot of fiscal 09' and 11' Home Funds and is a proposal for a \$160,000 to build a single family home for a lease to purchase program.

- Sabrina Waytes, Western Reserve Community Development was very thankful and mentioned that a recent completed project is at 100% occupancy and has been occupied with a nice, diverse mixture of people.

Commissioner Sines: This has been a very good partnership. Housing is probably the number one issue that we face in Lake County and what we can do to help is very important.

Commissioner Troy: Yes, it has been a great partnership and is very appreciated. We are reclaiming and redeveloping neighborhoods with a positive aspect in the community. Hopefully, the federal government will continue to send dollars, so that we continue to do these type of partnerships for affordable housing.
