A replacement a tax for the benefit of the Madison Fire District, for the purpose of providing and maintaining fire apparatus, appliances, buildings, or sites therefore, or sources of water supply and materials therefore, or the establishment and maintenance of lines of fire alarm telegraph, or the payment of permanent, part-time, or volunteer firemen, or to purchase ambulance equipment, or to provide ambulance or emergency medical services operated by a fire department at a rate not exceeding 2.48 mills for each one dollar of valuation, which amounts to 24.8 cents for each one hundred dollars of valuation, for a continuing period of time, commencing in 2013, first due in calendar year 2014.
