An additional tax for the benefit of Painesville Township for the purpose of providing and maintaining fire apparatus, appliances, buildings, or sites therefor, or sources of water supply and materials therefor, establishment and maintenance of fire alarms, payment of permanent, part-time, or volunteer firefighters or firefighting companies to operate same, including the payment of the firefighter employers contribution required under section 742.34 of the Revised Code, or the purchase of ambulance equipment, or the provision of ambulance, paramedic, or other emergency medical services at a rate not exceeding 2.9 mills for each one dollar of valuation, which amounts to 29 cents for each one hundred dollars of valuation, for a continuing period of time, commencing in 2013, first due in calendar year 2014.
