 To fund public infrastructure capital improvements by permitting the issuance of general obligation bonds

- 2 **KIRTLAND LOCAL SCHOOL DISTRICT - (7 PCT + Geauga)**
 Tax Levy - Emergency Requirements - \$1,450,000 - 4.61 Mills - Renewal - 5 yrs

- 2 **MADISON LOCAL SCHOOL DISTRICT - (12 PCT + Geauga)**
 Tax Levy - Current Operating Expenses and General Permanent Improvements
 4.99 Mills - Additional - CPT

- 2 **RIVERSIDE LOCAL SCHOOL DISTRICT - (27 PCT + Geauga)**
 Tax Levy - Necessary Requirements - 4.67 Mills - Substitute - CPT

- 3 **LAKE METROPARKS - (All precincts)**
 Tax Levy - Parks - 1.9 Mills - Renewal - 10 yrs

- 4 **MADISON VILLAGE - (2 PCT)**
 Tax Levy - Police - 3.8 Mills - Additional - CPT

- 5 **MADISON VILLAGE - (2 PCT)**
 Charter Amendment - By Petition - Reducing Council from seven (7) members to six (6) members effective 1/1/2016, and then to five (5) members, effective 1/1/2018

- 4 **PERRY VILLAGE - (1 PCT)**
 Shall the Ordinance providing for a one percent (1%) levy increase on income, to constitute a 2% tax rate, to be used for general operating purpose, effective July 1, 2014, be passed?
