POINTS TO REMEMBER!!

- ** Precinct officials may not discuss candidates or issues, or display any campaign materials.
- ** People may distribute campaign literature and conduct exit polls as long as they stand outside the limits of two small flags placed outside the entrance of the polling place.
- ** If there are any questions or problems, call the Lake County Board of Elections immediately! 350-2700 or 918-2700.
- ** The Polls are open from 6:30 A.M. until 7:30 P.M.
- ** Absentee Ballots **may not** be dropped off at the polling location.
- ** If a person has requested an Absentee Ballot, they must vote that Ballot, regardless of whether or not circumstances change the reason for the Absentee request.
- ** Polling locations have been consolidated. There is one sign-in table in the building for all precincts in the building.
