in the sum of \$1,450,000 and a levy of taxes to be made outside of the ten-mill limitation estimated by the County Auditor to average 4.06 mills for each one dollar of valuation, which amounts to 40.6 cents for each one hundred dollars of valuation, for a period of five years, commencing in 2009, first due in calendar year 2010?

A majority affirmative vote is necessary for passage.

Shall a levy substituting for two existing levies be imposed by the Riverside Local School District for the purpose of

providing for necessary requirements of the school district

in the initial sum of \$4,100,000, and a levy of taxes be made outside of the ten-mill limitation estimated by the County Auditor to require 3.84 mills for each one dollar of valuation, which amounts to 38.4 cents for each one hundred dollars of valuation for the initial year of the tax, for a period of five years, commencing in 2009, first due in calendar year 2010, with the sum of such tax to increase only if and as new land or real property improvements not previously taxed by the school district are added to its tax list? If approved, any remaining tax years on any of the two existing levies will not be collected after tax year 2008 (collection year 2009).
