

# Commissioners approve Emergency Operations Plan

**LAKE COUNTY - A** resolution adopting the 2015 Lake County Emergency Operations Plan was passed by the Lake County Board of Commissioners Feb. 11.

The plan is developed for all 23 communities in the county.

"Although the plan is reviewed annually, about every two or three years it is given a substantial overview and that's what happened this time," said EMA Director Larry Greene. "In 2015 there were some annexes added to it that involved functional needs folks, at risk, the school shooting plan was added for the law enforcement annex..."

He said it was determined that, with those changes, it would be good to seek approval.

Board President Dan Troy said he attended a National Association of Counties (NACo) meeting last year on disaster mitigation. It was noted having a countywide disaster plan in place was imperative.

"The last thing you want to do when something happens is sit there and say, 'Well what do we do next?'" Troy said.

He thanked Greene for the efforts of the EMA and the maintenance of the county disaster plan which

### DEPARTMENT
