

# Commissioners approve CDBG projects

LAKE COUNTY — The Lake County Board of Commissioners authorized execution of agreements with various entities and organizations for the FY-2012 and prior FYs Community Development Block Grant Funds at its Nov. 29 meeting.

"We're excited to get started on the FY12 projects," said Rhea Benton, CDBG manager. "We have over 12 projects this year, as you know, including public service, public improvements, housing programs and projects, also economic development with the two loan programs."

"There'll be activities involving rental assistance to certain special populations, as well as funds for North Coast Community Homes, to churches and rehab and to developmentally disabled adults," said Marian Norman, program manager for HOME.
