LAKE COUNTY - Lake County Commissioners Bob Aufuldish, Dan Troy and Judy Moran meet at 10 a.m. most Thursdays, with some meetings at 2 p.m. on Tuesdays, in the Commissioners' Chambers on the fourth floor of the Lake County Administration Building, 105 Main St., Painesville.

At the Sept. 26 meeting, the following resolutions were adopted:

RESOLUTIONS: ENGINEER'S DEPARTMENT

- Awarding a bid contract to Morton Salt for untreated bulk rock salt for the

Blackbrook and Madison garages in the amount of \$273,870.

UTILITIES DEPARTMENT

- Authorizing advertising for bids for wood chips with a bid opening date of Oct. 16.

- Authorizing advertising for bids for sawdust with a bid opening date of Oct. 16.

- Certifying unpaid sewer and water sums to the Lake County Auditor.

JOB AND FAMILY SERVICES DEPARTMENT

- Authorizing execution of Amendment #1 to the agreement with

Ohio Guidestone for a Worksfirst Program serving eligible Ohio Worksfirst participants. This is for a slight adjustment to the unit rate.

COMMISSIONERS' OFFICE

- Accepting the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the Lake County Auditor.

- Declaring the Lake

County Board of Commissioners' regular meeting schedule for the remainder of 2013.

The meetings for the rest of the year will be Thursdays, Oct. 3, 10, 17, 24, 31; Nov. 7, 21; Tuesday, Nov. 26; Thursdays, Dec. 12, 19; and finance only on Tuesday, Dec. 30.

- Awarding a bid contract to Grunwell-Cashero Company for the restoration of the Lake County Courthouse clock tower for \$150,100.

Bids ranged from \$150,100 to \$264,767.

- Providing for the issuance and sale, of not to exceed \$12 million of bonds of the county of Lake, to refund a portion of outstanding bonds of the county in advance of their final stated maturity and authorizing related matters.

- Approving the reduction of the membership of the Lake County Alcohol, Drug Addiction, And Mental Health Services (ADAMHS) Board to 14 members effective Jan. 1, 2014 as recommended by the ADAMHS

Board.

The board had consisted of 18 members.

- Awarding a bid contract in the amount of \$128,750 to Thermo-Eberline, LLC to supply 10 transportable, radiation portal monitors for Lake County's public safety forces.

The monitors are used to detect special nuclear materials.

FINANCE DEPARTMENT

- Approving payment of bills in the amount of \$1,340,497.37.

- Approving purchase orders in the amount of \$588,493.59.

- Increasing and decreasing appropriations for various general and non-general fund accounts.

- Transferring cash and appropriations within various general and non-general fund accounts.

EXECUTIVE SESSION

The commissioners adjourned to executive session to discuss collective bargaining and employment and real estate acquisition.
