# Stormwater rates reduced 50 percent

LAKE COUNTY — The Lake County Board of Commissioners approved reducing fees paid to the Lake County Stormwater Management Department by about 50 percent at its Nov. 29 meeting. The fees are the drainage charges for the Lake County Regional Sewer Water and Drainage District.

As per the sales tax package, the rates do reflect a 50 percent decrease for 2013, LCSWMD Director Tim Miller said.

Commissioner Dan Troy recounted how the Commissioners had increased the county sales tax by 0.5 percent early in the year, but promised other offsets including a

reduction of the inside property tax millage of 2.1 mills paid to the county by 1.1 mills and 50 percent reduction of the stormwater fees.

"We have already followed through on (the millage reduction) by virtue of our passage of the tax budget, which indicates to the county auditor that's what we're asking to be collected in 2013," Troy said.

The resolution the Commissioners approved advises the county auditor the stormwater fees are to be reduced in 2013 as well.

When asked, Miller advised the LCSWMD collected \$2,043,827 from property owners in member communities. The expected rev-
