**RESOLUTION AWARDING A BID CONTRACT TO KARVO PAVING COMPANY IN THE AMOUNT OF \$732,130.75 FOR THE MCMACKIN ROAD RESURFACING PROJECT, MADISON TOWNSHIP, OH - LPA PID #93297 - FEDERAL AID PROJECT FAN #E(130)328**

WHEREAS, the Board of County Commissioners hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board of County Commissioners, and that all the deliberations of this Board of County Commissioners and of its committees, if any, which resulted in formal actions, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code; and

WHEREAS, the Lake County Engineer recommended to the Board of Lake County Commissioners to advertise for bids for the McMackin Road Resurfacing Project; and

WHEREAS, bids were received by the Board of Lake County Commissioners on March 11, 2015, in accordance with specifications and proposal forms as prepared by the Lake County Engineer; and

WHEREAS, the Lake County Engineer has reviewed bids received and has recommended the award of a contract be made in accordance with said proposal to Karvo Paving Company, 4524 Hudson Drive, Stow, Ohio, 44224, it being the lowest and best bid received.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners, in and for Lake County, Ohio, hereby awards a bid contract to Karvo Paving Company in the amount of \$732,130.75. Said Contract incorporated herein and made part of this resolution by reference.

BE IT FURTHER RESOLVED, that the Clerk of the Board is hereby directed to forward certified copies of this resolution to the Lake County Auditor; Lake County Engineer; Terri Lange, Commissioners' Office; and to Karvo Paving Company, 4524 Hudson Drive, Stow, Ohio, 44224 - Attn: Mr. George Karvounides, President.


