The following change is incorporated in the Specifications - *Alternate Bid Materials*, A. – *ITEM 448 – ASPHALT CONCRETE SURFACE COURSE, TYPE 1, AS PER PLAN*, shall meet the requirements of ODOT 448, except the **PG 70-28M** asphalt binder shall be modified with chemically-bound Ground Tire Rubber as shown in the Appendix. If this alternate is used on the project, all material and testing requirements found in the Specifications shall apply.
