Commissioner Moran presented the following resolution and moved its adoption.

**RESOLUTION AWARDING A BID CONTRACT TO JTO, INC. FOR THE VROOMAN ROAD – SR 86 - ROUNDABOUT PROJECT, OPWC PROJECT NO'S. CG04P AND CG05P, IN THE AMOUNT OF \$1,468,698.56**

WHEREAS, the Board of County Commissioners hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of deliberations of this Board of County Commissioners and of its committees, if any, which resulted in formal actions, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code, and

WHEREAS, the Lake County Engineer recommended to the Board of Lake County Commissioners to advertise for bids for the Vrooman Road – SR 86 - Roundabout; and

WHEREAS, bids were received by the Board of Lake County Commissioners on April 24, 2013 in accordance with specifications and proposal forms as prepared by the Lake County Engineer; and

WHEREAS, the Lake County Engineer has reviewed bids received and has recommended that award of contract be made in accordance with said proposal to JTO, Inc., 6011 Heisley Road, Mentor, Ohio 44060, it being the lowest and best bid received.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners, in and for Lake County Ohio, hereby award a bid contract to JTO, Inc. for the Vrooman Road – SR 86 – Roundabout in Leroy Township, Ohio in the amount of \$1,468,698.56.

BE IT FURTHER RESOLVED that the Clerk of the Board is hereby directed to forward certified copies of this resolution to Terri Lange of the Commissioners' Office, the Lake County Auditor; the Lake County Engineer; and to JTO, Inc., 6011 Heisley Road, Mentor, OH 44060.
