**RESOLUTION AWARDING A BID CONTRACT TO BECDIR CONSTRUCTION COMPANY IN THE AMOUNT OF \$142,045.25 FOR ST. CLAIR STREET BRIDGE REMOVAL PROJECT IN WILLOUGHBY, OH – LPA PID #93375**

WHEREAS, the Board of County Commissioners hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of deliberations of this Board of County Commissioners and of its committees, if any, which resulted in formal actions, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code, and

WHEREAS, the Lake County Engineer recommended to the Board of Lake County Commissioners to advertise for bids for the St. Clair Street Bridge Removal, and

WHEREAS, bids were received by the Board of Lake County Commissioners on April 17, 2013, in accordance with specifications and proposal forms as prepared by the Lake County Engineer, and

WHEREAS, the Lake County Engineer has reviewed bids received and has recommended that award of contract be made in accordance with said proposal to BECDIR Construction Company, 1564 W. Akron-Canfield Road, Berlin Center, OH 44401, it being the lowest and best bid received:

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners, in and for Lake County Ohio, hereby awards a bid contract to BECDIR Construction Company in the amount of \$142,045.25. Said Contract incorporated herein and made part of this resolution by reference.

BE IT FURTHER RESOLVED that the Clerk of the Board is hereby directed to forward certified copies of this resolution to the Lake County Auditor; the Lake County Engineer; Terri Lange; and to BECDIR Construction Company, 15764 West Akron-Canfield Road, Berlin Center, OH 44401 – Attn: Mr. David A. Dirusso, President.


