

The Board of County Commissioners, in and for Lake County, Ohio, met this day in regular session with the following members present:

Commissioner Moran presented the following resolution and moved its adoption.

**RESOLUTION AWARDING A BID CONTRACT IN THE AMOUNT OF \$329,240.50 TO BARBICAS CONSTRUCTION CO., INC. FOR THE BLASÉ-NEMETH ROAD WIDENING PROJECT IN PAINESVILLE TOWNSHIP, OHIO - OPWC #CG21P/CG22P**

WHEREAS, the Board of County Commissioners hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board of County Commissioners, and that all the deliberations of this Board of County Commissioners and of its committees, if any, which resulted in formal actions, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code, and

WHEREAS, the Lake County Engineer recommended to the Board of Lake County Commissioners to advertise for bids for the Blasé-Nemeth Road Widening Project, and

WHEREAS, bids were received by the Board of Lake County Commissioners on February 20, 2013, in accordance with specifications and proposal forms as prepared by the Lake County Engineer, and

WHEREAS, the Lake County Engineer has reviewed bids received and has recommended that award of contract be made in accordance with said proposal to Barbicas Construction Co., Inc., 124 Darrow Road - Ste. 1, Akron, Ohio, it being the lowest and best bid received.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners, in and for Lake County, Ohio, hereby awards a bid contract to Barbicas Construction Co., Inc. in the amount of \$329,240.50. Said Contract incorporated herein and made part of this resolution by reference.

BE IT FURTHER RESOLVED, that the Clerk of the Board is hereby directed to forward certified copies of this resolution to the Lake County Auditor; Lake County Engineer; Terri Lange, Commissioners' Office; and to Barbicas Construction Co., Inc., Attn: Mr. Jared L. Giles, 124 Darrow Road - Ste. 1, Akron, Ohio 44305-3835.


