ADDENDUM NO. 1

The following is Addendum No. 1 to the bid documents for: Vrooman Road – S.R. 86 – Roundabout.

1. Maintenance of Traffic Notification Requirement – The Contractor shall notify all local businesses, fire and safety, Township and others as directed by the County Engineer's office approximately one week before the initial road closure and before beginning a new detour phase. Contact list will be provided in the preconstruction meeting.
2. The attached Utilities 4A Note shall be included and made part of the bid documents. All utility coordination as required shall be included in Item 624 – Mobilization (Reference #71).
3. Item 619 – Field Office, Type "B" (Reference #69) shall have the estimated quantity revised from 18 months to 8 months.
4. Item 452 – 8" Non-Reinforced Concrete Pavement, As Per Plan (Reference #32) shall have a brick stamp pattern with the appearance as shown on sheet 2 of 76 in the plans. The coloring shall provide a "red brick" paver appearance. A mockup of the stamped and colored concrete shall be provided to the County for approval.
5. Item 304 – Aggregate Base, As Per Plan (Reference #21) shall be per specification Item 3.B. Crushed concrete meeting the specified gradation is acceptable.
6. Replace field access drive and curb cut at Station 103+98 to Station 104+16 LEFT.

7. Add 12" Conduit, Type "B"
Left swale line: Sta. 103+93, invert = 946.00 to Sta. 104+21, invert = 945.90
Item 603 – 12" Conduit, Type "B" (Reference #44) shall be revised from 172 Ft. to 202 Ft.
8. Revise CB 2-3 Sta. 105+50 Lt. from grate elevation 946.58 to elevation 945.48.
9. Item 832 – Erosion Control (Reference #122) shall be revised from 45,000 to 20,000 EACH.
10. The attached Revised Proposal shall replace the proposal that is currently in the bid documents.

This addendum shall be attached to the proposal and become part of the bidding document to verify receipt of same.

Utilities 4A Note

Bidders are advised that the following utility facilities are in the project area. These utility facilities shall be relocated within the construction limits of the project as set out below.

Orwell-Trumbull, Cobra Pipeline

The company has existing facilities in the area of the project that will need to be relocated. The county is coordinating with Orwell-Trumbull/Cobra Pipeline. No schedule is available at this time.

The Illuminating Company

The company has existing facilities in the project area. The power lines in the area will require permanent pole adjustments in order to avoid conflicts with proposed plan. The relocation plans have been received and approved. They have pre-construction activities planned for May, 2013 (see the attached Illuminating Company letter). Contractor shall give The Illuminating Company 2 weeks notice prior to the end of the project such that they can schedule their post construction activities accordingly.

AT&T Ohio

The company has aerial and underground facilities within the project area. They have been contacted. No plans for relocation have been submitted to date.

Time Warner Cable

The company has aerial facilities within the project limits. This facility will require detachment from the existing poles and re-attachment to the new poles. The county and The Illuminating Company will coordinate the demolition procedures with Time Warner Cable.

The Contractor shall use extreme caution when working in proximity to existing utility facilities.

Sections 105.07 and 107.16 of the Ohio Department of Transportation Construction and Material Specifications require, among other things, that the contractor cooperate with all utilities located within the limits of this construction project and take responsibility for the protection of the utility property and services.

The following information indicates the Illuminating Company's findings after examining the information previously received by the Illuminating Company on 10/15/2012 for the aforementioned project.

- ☐ 1. The Illuminating Company has no facilities in conflict on this project.
- ☐ 2. Rearrangement of the Illuminating Company's facilities is not necessary.
- ☒ 3. **The Illuminating Company has facilities in conflict and will be required to rearrange them.**
- ☐ 4. Based upon plans or information received, it is indeterminate if rearrangement of our facilities is necessary. Please provide the additional information requested below.

Prior to the Illuminating Company commencing work on aerial or underground facilities in support of roadway, sanitary, storm or water line projects, all clearing, grubbing, necessary forestry (tree/bush trimming) in the Public Right of way is to be completed by others. Final grade shall be established prior to the Illuminating Company installing or relocating underground electric distribution facilities. Also, the project construction limits are to be surveyed and staked by the requesting engineering consulting firm or by the municipality in order ensure the Illuminating Company is properly locating aerial facilities in the public right of way and within the construction limits.

Relocation costs that are determined to be compensable, such as, sanitary sewer projects, water lines and other compensable rights or where the relocation of our overhead facilities is only caused by the installation of sidewalks, shall be invoiced by the Illuminating Company per our standard Aid to Construction form. Payment shall be received in advance of work commencing. Estimates are only valid for 30 days and will be re-estimated to provide current estimated costs should approvals be extended beyond the 30 days.

In the event additional conflicts are identified which are not part of the Project 4A Note/Project Response Form, due to field conditions, the Illuminating Company shall be notified immediately, both verbally and in writing by the authorized agent for the project. The Illuminating Company, along with the contractor and authorized agent for the project, shall resolve the field conflicts and determine if there are associated compensable costs. The Illuminating Company will not accept contractor delay costs that the Company has not had opportunity to dispute or resolve.

Important! Illuminating Company High-Voltage Transmission lines can not readily or easily be de-energized. They operate under strict Federally-Mandated oversight. De-energizing is a lengthy, costly process, and all other options must be exhausted prior to considering de-energizing High-Voltage Transmission lines. Permission to de-energize may be withheld depending on many factors, including but not limited to: ambient temperature, customer load, possible weather events, and many other contingencies. Further, if de-energizing is ultimately allowed, the High-Voltage Transmission lines must remain in a condition that they can be "restored" to service in an emergency. Therefore, any personnel, tools, equipment and all appurtenances must be

in a position and condition to move/reposition (within two-hours of notice) into a safe, OSHA-acceptable distance from the High-Voltage Transmission lines, and the High-Voltage Transmission lines must be considered as energized while steps are taken to re-energize the High-Voltage Transmission lines. Payment shall be received in advance of work commencing. Estimates are only valid for 30 days and will be re-estimated to provide current estimated costs should approvals be extended beyond the 30 days.

Wire work as noted on WR 55835526.pdf Wire Work Before Road Construction Begins.

Post Construction Activities include but not limited to:

Symbol #7 New Pole 735726 to be set at STA 107+07 08' LT.
Symbol #11 Pole 278938 pole to be relocated from STA 207+47 46' RT to STA 207+80 40' RT Telephone to remove pole.
Wire work as noted on WR 55835526.pdf: Wire Work After Road Construction Has Been Completed.

Work Week:

The Illuminating Company's workweek is comprised of 5 days per week, 8 hours per day, Monday through Friday. Any overtime costs incurred, as a result of contractor project escalation or requests from ODOT, Cuyahoga County or other project administering agencies shall be billed directly to the contractor. Authorization for payment for the requested overtime shall be received in advance of the overtime being worked.

Additional Comments:

For the purposes of 29 CFR 1926 Subpart CC, the electric distribution facilities proximate to the structure are energized at less than 50,000-Volts All contractors/owners must know & comply with Occupational Safety Health Administration (OSHA) safe-working clearances between persons or any conductive object and energized bare wires.

Notice: The Illuminating Company denies permission to any contractor or other utility to remove Illuminating Company manhole castings, cut down Illuminating Company manhole necks, and to temporarily plate over project-created Illuminating Company manhole roof openings. This practice often results in construction debris falling into manholes, thus damaging energized circuits. Under any circumstances if project construction debris is found in Illuminating Company manholes on the subject project, the Illuminating Company shall charge the responsible party for the required clean out. In the event circuitry is damaged as a direct result of project construction debris, the Illuminating Company shall also file a claim, and pursue reimbursement for the damage. It is the Project General Contractor responsibility to notify the Illuminating Company in advance of any existing debris found in Illuminating Company manholes.

Notice: Customer-owned secondary cables/wire and equipment that requires relocation caused by a public works project is not the responsibility of The Illuminating Company. The relocation cost for customer owned facilities generally is the responsibility of the requesting agency.

Notice: In the event of a major storm in our service territory, the Illuminating Company's priority becomes the safety of the general public and employees. Efforts are directed to the safe and timely restoration of electrical service to our customers which may affect the projects overall schedule.
