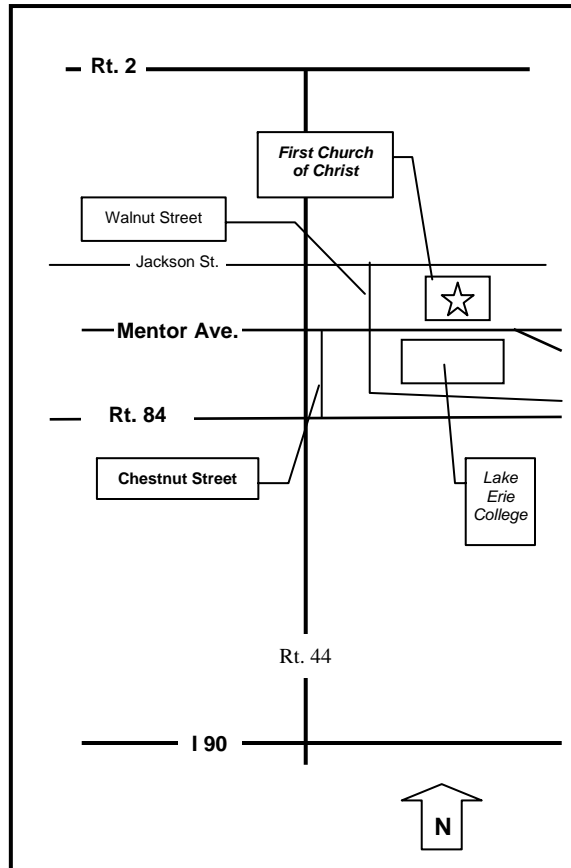

**Directions:**

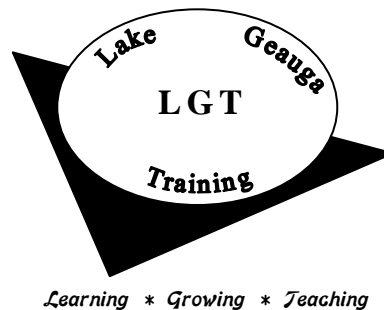
