8. RESOLUTION SUPPORTING THE CHILD SUPPORT PROTECTION ACT OF 2011 (S.195) AND URGING OHIO SENATORS BROWN AND PORTMAN TO VOTE FOR THE BIPARTISAN LEGISLATION TO PERMANENTLY RESTORE FULL FUNDING FOR THE CHILD SUPPORT ENFORCEMENT PROGRAM, TO RETURN AUTHORITY TO STATES TO UTILIZE CHILD SUPPORT INCENTIVES TO FUND PROGRAMS, AND TO CONTINUE THE INCENTIVES PROGRAM TO REWARD EFFICIENT ENFORCEMENT EFFORTS (20110201\C02) (C-107)

Commissioner Troy: This issue was discussed at our last meeting that the lapse had taken place through the expiration of federal legislation allowing incentives to be used for child support enforcement. There has been legislation introduced in the new Congress in the United States Senate by Senator Jay Rockefeller of West Virginia and he has bipartisan support with Republican Senators John Cornyn of Texas and Olympia Snowe of Maine, and Democrat Senator Herb Kohl of Wisconsin. This resolution urges the Senate, including our Ohio Senator Brown and Senator Portman, to support this legislation based on its being essential to enforcing child support obligations to ensure that the rightful obligees pay for the support of their children.

Commissioner Aufuldish: This resolution indicates that the congressional research service reports that the receipt of child support reduces child poverty by 25%.

Commissioner Sines and Matt Battiato, Director of Job and Family Services briefly discussed that this is supported by Congressman LaTourette.

Commissioner Troy: The National Association of Counties (NACO) is pushing this very strongly and has urged member counties based throughout the country to pass resolutions of support and/or contact their federal representatives.
