The Contractor shall coordinate all other details with the Painesville Building Department and Lake County Building Department. All permits shall be obtained by the Contractor and all permit, review and inspection fees shall be paid by the Contractor:

## **SPECIFIC PROJECT REQUIREMENTS**

1. Section 8 –WORKERS BACKGROUND CHECK **ADD:** In its entirety.

### **8 - WORKERS BACKGROUND CHECK**

- 8.1 Pursuant to R.C. 3319.391, Contractors shall perform or cause to be performed through the Ohio Bureau of Criminal Investigation and Identification a criminal background check for any of its employees working in Lake County, such background check to include information from the Federal Bureau of Investigation. Background checks for such employees must be performed prior to working in Lake County and every five years thereafter. If the background check reveals a conviction or guilty plea to any of the offenses described in R.C. 3319.39(B) (1), such individual shall not be hired to perform any work in the Lake county, or, if already working in Lake County, shall be immediately released from working in the Lake County, unless the individual has been “rehabilitated” within the meaning described in R.C. 3319.39(E). Contractor is solely responsible to ensure the requirements of this paragraph are complied with, and shall warrant to the appropriate County official in writing that the requirements of this paragraph have been or will be complied with. The requirements of this paragraph shall continue in effect unless and until R.C. 3319.391 is repealed, declared unconstitutional, or otherwise becomes moot.

## **DRAWINGS**

1. Drawing A-1, Alternate A-1: **REVISE:** Change Door No. 01 (Main Entrance) and Door No. 2 (Interior Vestibule) from a swing door system to an exterior and interior, sliding, power operated automatic entrance as specified in Specification Section 084229. Interior vestibule door to be set flush with interior wall to accommodate operator. Replace all jamb/head materials in opening with matching cabinets.
2. Drawing A-1, **DELETE:** “Note: Coordinate the reinstallation of contacts on the exterior doors with Owner security provider”. **ADD:** All security demolition / reinstallation by the Owner.
3. Drawing A-3, Toilet Room Partial Plans: **ADD:** “Note: Provide operators on both sides of the Toilet Room doors (typical). Field verify exact locations”.
4. Drawing A-4, Prosecutor’s Office Building, Partial Plan West Employee Entrance. **ADD:** “Note: Existing card reader & disconnection provided by Owner”.
5. Drawing A-5, Plans No. 2 and No. 3. **REVISE:** Note: At glazed vestibules, provide bronze colored wire mold (match existing color) for power conductors to new operators in exposed areas.
