The Lake County Board of Commissioners announces the proposed projects to be funded with the Fiscal Year 2009 allocation of Community Development Block Grant, HOME Investment Partnership and American Dream Downpayment Initiative funds from the U.S. Department of Housing and Urban Development (HUD).
