to de-water 5,000 tons of anaerobically digested sludge and to concentrate 3,000 tons of waste activated sludge.

Bid proposals must be accompanied by Certified Check, Cashiers Check, Money Order or an Irrevocable Letter of Credit made payable to the County of Lake or by an original Bid Bond in favor of the County of Lake and signed by a Surety Company licensed to do business in the State of Ohio, in the amount of five percent (5%) of the bid, conditioned such that the successful bidder shall execute a contract in conformity with the invitation and the successful bid.

No bidder shall be considered a responsive and responsible bidder or eligible to be awarded the contract to which this Notice or Bid Specifications apply unless the bidder has completed a certification that the bidder is in compliance with R.C. 2909.33. A copy of the certification is included with the instructions to bidders and must be submitted with the bid.
