This project consists primarily of the construction of the following:

The installation of approximately 5,503 feet of 12" and 8" ductile iron water main, one hundred and seventeen (117) service connections and seventeen (17) hydrants within the right-of-way of Robinhood Dr. and Kilarney Dr., in the City of Willoughby, Ohio. The project also includes: related appurtenances, pavement and drive replacement, utility support, maintenance of traffic per Ohio Department of Transportation standards, and site restoration.

Bids must be in accordance with specifications and on forms available from Stephen Hovancsek & Associates, Inc. located at Two Merit Drive, Richmond Heights, Ohio 44143 at a non-refundable cost of One Hundred Dollars (\$100.00) picked up or One Hundred and Twenty Five Dollars (\$125.00) mailed.

Each proposal must be accompanied by a certified or cashiers check, or an irrevocable letter of credit in the amount of ten percent (10%) of the amount bid or a bid bond in the amount of 100% of the amount bid, such check or bid bond to be payable to the Board of Lake County Commissioners, and to be held as a guarantee that in the event the bid is accepted and a contract awarded to the bidder, the Contract will be duly executed and its performance properly secured.

Each individual employed by the Contractor or any Subcontractor and engaged in work on the project under this contract shall be paid the prevailing wage established by the Department of Industrial Relations of the State of Ohio. This shall occur regardless of any contractual relationship which may be said to exist between the Contractor or any Subcontractor and such individual.

The successful bidder(s) will be required to furnish a bond for faithful performance of the Contract in a sum of not less than one hundred percent (100%) of the total price bid for the complete work, said bond to be that of an approved surety that is listed on the most current Department of the Treasury Circular 570, "Surety Companies Acceptable on Federal Bonds".

All proposals shall be sealed in individual envelopes, endorsed for "Robinhood Dr. and Kilarney Dr. Waterline Replacement; Contract 296-W, Lake County, Ohio," addressed and delivered to the Clerk of the Board of Lake County Commissioners, Lake County Administration Center, 105 Main Street, 4th Floor, Painesville, Ohio 44077. Said proposals shall be on proposal blanks furnished with the specifications.

The Owner reserves the right to reject any or all bids, to waive any informalities or irregularities in the bids received, request additional information on experience and/or equipment, and to accept any bid which it deems most favorable. No bidder shall be considered a responsive and responsible bidder or eligible to be awarded the contract to which this Notice or Bid specification apply, if the bidder is listed on the Auditor of State's Database as having an unresolved "Finding of Recovery" as that term is defined in R.C.9.24. No bidder shall be considered a responsive and responsible bidder or eligible to be awarded the contract to which this Notice or Bid Specifications apply unless the bidder has completed certifications that the bidder is in compliance with R.C. 3517.13 and R.C. 2909.33. Copies of the certifications are included with the instructions to bidders and must be submitted with the bid.
