

LEGAL NOTICE TO BIDDERS

Sealed bids will be received by the Board of Lake County Commissioners in and for Lake County at their office in the Lake County Administration Center, 105 Main Street, 4th Floor, Painesville, Ohio; up to the hour of 11:00 AM Local Time on February 18, 2009, and read publicly thereafter in the Commissioners Chambers at the above address, for the following improvement project:

New & High Street Sanitary Sewer Replacement Project No. 308-S

Estimate of Cost: \$__254,000.00_____

Said improvements shall be in accordance with specifications and proposal forms on file with the Clerk of the Board of Lake County Commissioners. The Bid Package may be obtained upon receipt of payment of \$_35.00_ (NON REFUNDABLE) from eBlueprint, by contacting Steve Harper (216-522-0911), by going to any eBlueprint location, or by logging onto www.eblueprint.com. Checks shall be made payable to AECOM and shall be given to eBlueprint.

The work covered by the plans and specifications generally includes: _constructing a new sanitary sewer on New Street and connecting existing laterals, constructing a new sanitary sewer on High Street and connecting existing laterals, and abandoning a section of existing 8-inch sanitary sewer on High Street. All work under this contract shall be fully completed within (120) days from the Notice to Proceed.

Proposals shall be addressed to the Board of Lake County Commissioners, Lake County Administration Center, 105 Main Street, Painesville, Ohio 44077, and marked **BID FOR THE NEW & HIGH STREET SANITARY SEWER REPLACEMENT PROJECT NO. 308-S.**

Pursuant to R.C. 153.01 et. eq., the bid must be accompanied by an original sealed document in the form of a bond for the full amount (100%) of the bid, OR by a certified check, cashiers check, or irrevocable letter of credit equal to ten percent (10%) of the amount bid, drawn on a solvent bank located in Lake County and payable to the Treasurer of Lake County, Ohio, as surety that if the proposal is accepted, a contract will be entered into and its performance properly secured. Should any bid be rejected said surety shall forthwith be returned to the bidder and should any bid be accepted such bid bond, certified check, cashiers check, or letter of credit will be returned to the bidder upon proper execution and securing of the contract.

No bidder shall be considered a responsive and responsible bidder or eligible to be awarded the contract to which this Notice or Bid Specifications apply, if the bidder is listed on the Auditor of States Database as having a Finding of Recovery as that term is defined in R.C. 9.24. No bidder shall be considered a responsive and responsible bidder or eligible to be awarded the contract to which this Notice or Bid Specifications apply unless the bidder has completed a certification that the bidder is in compliance with R.C. 3517.13. A copy of the certification is included with the instructions to bidders and must be submitted with the bid.

Proposals shall be subject to the conditions that the right is reserved to hold bids for a period not longer than sixty (60) days after date of bid opening and/or to award the contract at any time during said period.

The successful bidder will be required to execute the contract within ten (10) days after the award of the work to him/her, and he/she shall furnish acceptable bond or surety, if not filed previously to the satisfaction of the County of Lake, Ohio for the faithful performance of said contract in the sum of one hundred percent (100%) of the total amount of the bid. In case of failure to execute the contract as stated or to furnish bond and/or surety, the bidder shall be considered to have abandoned the contract and is then liable for the difference between his/her bid and the next lowest bid, not to exceed ten percent (10%) of the amount bid. All contractors and subcontractors involved with the project shall comply with the provisions of Revised Code 2909.33 by filing the Declaration regarding Material Assistance / Non-Assistance to a Terrorist Organization. A copy of the Declaration is included with the Instructions to Bidders.

The County reserves the right to reject any or all bids, or to increase or decrease or omit any item or items and/or to award to the lowest and/or best bidder. Each proposal must contain the full name of every person or company interested in the same.

Wage Rates for each employee employed by the contractor or any subcontractor and engaged in work on the project under this contract shall be paid the prevailing wage established by the Department of Industrial Relations of the State of Ohio, as provided by the appropriate Sections of the Ohio Revised Code. This shall occur regardless of any contractual relationship which may be said to exist between the contractor or any subcontractor and such employee.
