Bill Margalis, Administrative Director: The changes that were negotiated in this contract are almost identical to the ones of our contract with CWA that was passed a couple of months ago.

Commissioner Troy: There is a small bargaining unit within the Prosecutor's Office, primarily clerical folks who are represented by the Communications Workers of America. This is a 3-year contract for 2012-2014 with a zero percent raise in 2012, a 2.5 percent raise in 2013, and a 2.5 percent raise in 2014. There have been some changes in terms of sick leave that the county had asked for, and we are also adding the day after Thanksgiving as a holiday and changing the option of Christmas Eve or New Years Eve.
