**RESOLUTION SETTING THE DATE, TIME, AND PLACE FOR A PUBLIC HEARING ON THE PROPOSED NAME CHANGE OF SOUTH ROAD IN CONCORD TOWNSHIP (Hearing: Tuesday, November 16, 2010 at 2:00 p.m. in the Commissioners' Chambers, 105 Main Street, Painesville, OH 44077)**

WHEREAS, the Board of County Commissioners hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board of County Commissioners, and that all the deliberations of this Board of County Commissioners and of its committees, if any, which resulted in formal actions, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code, and

WHEREAS, the Board of Lake County Commissioners has received a petition requesting the name change of South Road in Concord Township; and

WHEREAS, pursuant to Chapter 5541.04 of the Ohio Revised Code, the Board must set the date, time and place for a public hearing on the petition to change the name of South Road and to notify abutting property owners of the proposed name change and the date of the hearing; and

WHEREAS, this Board desires to set the date, time, and place for a public hearing on the proposed name change of South Road in Concord Township, and

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners, in and for Lake County, Ohio, hereby sets Tuesday, November 16, 2010 at 2:00 p.m. in the Commissioners' Chambers, 105 Main Street, 4<sup>th</sup> floor, Painesville, OH 44077 as the date, time, and place for a public hearing on the proposed name change of South Road in Concord Township.
