CALL TO ORDER: Commissioner Troy called the meeting to order at 10:05 am, Thursday, February 25, 2010.

Brian Humphrey of the Painesville Census Office gave a brief overview of the upcoming April 1, 2010 Census. The census survey will be received through the mail mid March and consists of 10 questions. The survey should take approximately 10 minutes to complete and returned promptly in the pre-addressed, postage paid envelope. Mr. Humphrey's indicated that tremendous efforts are made to ensure confidentiality, accuracy and to process the information quickly.

Commissioner Troy: The primary reason for the census being part of our Constitution from day one was to determine populations for purposes of congressional representation, and it is now also used to determine criteria and eligibility for certain federal programs.

Bill Margalis, Director of Administrative Services: The stop loss insurance for our Workers Compensation continues to be good news. This is a reduction of approximately 20% from last year. - Lake County Job and Family Services will continue determination of eligibility for those individuals who apply for child care assistance costs and for certification of daycare homes.
- As of April 1, 2010 the daycare centers and daycare home providers will contract with the State Department of Job and Family Services who will pay them directly. Lake County Job and Family Services will be removed from this equation.
- As of April 1, 2010 daycare home providers will be part of a collective bargaining agreement.
- Lake County Job and Family Services will be a resource for the daycare providers and daycare home providers during this transition.
