CALL TO ORDER: Commissioner Sines called the meeting to order at 10:10 am, Thursday, May 5, 2011.

Niles Oinonen, 406 E. Street, Fairport Harbor addressed the Board regarding sanitary sewer back-ups that have been happening in the homes on E. Street, and some other areas in Fairport.

- Randy Rothlisberger, Director of Water Systems commented on what the department has been doing in pursuit of rectifying these issues. Mr. Rothlisberger will be meeting with Fairport Harbor representatives next Tuesday to discuss a plan to address the private property laterals that are compounding the flooding problems.

- Tim Hadden, 622 Vine Street, Fairport Harbor addressed the Board requesting that these flooding issues become a priority. Mr. Hadden also said that Randy and his group have been more than accommodating regarding the Fairport issues.

- The sanitary sewer system in Fairport Harbor was aged and challenged when the county originally took it over, and has been an ongoing effort for the Utilities Department.

- Jim Braemer, 535 5th Street, Fairport Harbor discussed his basement flooding, Fairport Nursery Road flooding, and a green box near Hemisphere's driveway with the Utilities Department.

- The Commissioners will continue to work with Fairport Harbor to alleviate these issues.

- Mr. Hadden will provide the Commissioners with a list of concerns that will be directed to the appropriate departments within the county.

Commissioner Aufuldish: I would like to thank the communication workers for their ability to work well with this Board of Commissioners, and understanding our height of fiscal problems that the county is experiencing. The key to this agreement is their wage rates will be frozen from April 1, 2011 - March 31, 2012. The folks in the union have also agreed to take extra furlough days.

Bill Margalis, Administrative Director: This one year contract is unusual because traditionally we have signed three year agreements with our bargaining unit. Through the negotiation process the union and the Commissioners recognized that we do not fully understand what will happen with Senate Bill 5 in terms of collective bargaining and this will allow possible negotiations with any upcoming changes. Next year, at this time we will sit down again and see if any changes are needed. Back in 2002, there

were 117 members in the bargaining unit, and as of today there are 84. I thank the union for understanding our position financially. Mike Matas and myself were able to negotiate this contract without an outside consultant, which has saved us some dollars.

- Erica Seibert, Union Representative commented that the union understands the economic situation. The union was glad that they were able to come to a negotiation and felt that this was in the best interest of the union and the Commissioners.

Commissioner Troy: I too would like to salute CWA for working with us on this, and we appreciate the fact that they understand that we are doing the best that we can.

Commissioner Sines: Again, thank you. We are all trying to do our best in a bad situation, and to move forward in a positive way.

OLD BUSINESS: There was no old business.

NEW BUSINESS: Commissioner Troy: There was an election Tuesday in Lake County. The local news media editorialized that entities should have the choice of when they want to go to the ballot. The overall turnout was 15%, and in Kirtland less than 10%. It is a tremendous cost per voter to put the elections board apparatus into effect when you are only getting about 1 of every 7 registered voters showing up. The media said there is nothing wrong with these elections because the county gets reimbursed in the following year. Just because the tax expenditure is coming from another entity doesn't make an unwise expenditure a wise one! It's still tax dollars! I guess it was a good day for pollworkers to catch up on their reading and exchange recipes!

Commissioner Troy: I did have the opportunity on Tuesday along with 75 or so other county officials from throughout America to attend a White House County Officials Meeting. A very impressive five cabinet secretaries met with us, Vice President Biden came in and spoke to us, and then we were very surprised when President Obama came in and met with the group. Discussion took place regarding issues such as rehabilitation and corrections, infrastructure and sustainable communities, changing Medicaid into a block grant program, and a presentation on the Health Reform Act. These representatives of our federal administration felt that county government was very important and referred to the counties as partners. President Obama said it was great opportunity to take a break from Congress, and meet with people that actually know what is going on out there in terms of county government issues. It was a very good meeting, and I was very happy to attend.

PUBLIC COMMENT: Brief discussion took place when John Muzik of Painesville Township inquired about sheriff patrol and the distribution given to the cities, villages and townships. Commissioner Troy: There is no grant money that flows from the county to different communities. The county provides a vast array of state mandated services to all communities like running the jail, courts, elections, property recording, property valuation, collection of taxes, and bridges and county roads taken care of by the Engineer's Office. My idea of a township is a rural area that does not have a lot of demand for services. But, what has happened is Painesville Township and Concord Township have grown; they are the largest townships in Northeast Ohio in terms of population. It is up to the citizens of these townships as to what type of law enforcement protection they want, and it really is up to them to pay for it!
