CALL TO ORDER: Commissioner Sines called the meeting to order at 10:05 am, Thursday, May 24, 2012.

Maureen Orndorff, Soil & Water Conservation District: The Commissioners are honoring Mark and Chris Gilson today because they have put an agricultural conservation easement on their nursery in North Perry Village. It is the first nursery land agricultural easement with the Federal Farm and Ranch Land Protection Program, which the Commissioners have supported. The Gilsons have been very active in conservation, protecting and preserving the nursery industry. I am very pleased to have been working with them on this project over the last year and a half.

- Commissioner Sines read the special resolution on behalf of the Commissioners recognizing the Gilson Family. Commissioner Sines said it's great to see a family business that has been in business for over 60 years and that they are having such a great year. This is the first nursery easement in the United States, which is unique in itself. Congratulations!

- Mr. Gilson thanked the Commissioners for their recognition and support in terms of the nursery industry, Maureen and the Soil & Water Conservation staff who has worked tirelessly on this effort, and the people of North Perry.
