In light of the events of 9-11, this Court is taking additional steps to ensure your security as well as the security of the citizens of Lake County, Ohio. This application incorporates revisions in the Ohio Constitution and statutory law, and to protect your privacy interests.

The following are the general rules: A male of at least 18 years of age and a female of at least 16 years of age, not nearer of kin than second cousins, and not having a husband or wife living may be joined in marriage. A marriage may only be entered into by one man and one woman. Further, a marriage between persons of the same biological sex is against the Ohio Constitution and the laws of this state. There are some additional requirements if you are under the age of 21.
