### RECORD OF HOURS OF SERVICE

*It is your responsibility to obtain a record of the hours of community service you have performed at the work-site.*

*You must fill in the worksite name, phone, contact person and worksite address on the Record of Service Hours form.*

*You must ask your worksite supervisor to complete the form provided and sign the form after each work session.*
