

## **LEGAL NOTICE TO BIDDERS**

Sealed bids will be received by the Board of County Commissioners for Lake County, Ohio at their office in the Lake County Administration Center, 105 Main Street, 4<sup>th</sup> Floor, Painesville, Ohio 44077; up to the hour of 11:00 AM Local Time on **Wednesday, November 28, 2018**, and read publicly thereafter in the Commissioners' Chambers at the above address, for the following improvement project:

### **Maple Grove and Rockefeller I-90 Crossing Improvements – Project No. 363-W - 2018**

Engineer's Estimate of Cost: \$715,000.00

The work covered by the plans and specifications includes: City of Wickliffe: Installation of approximately 670 LF of 8-inch DIP and 10-inch HDPE diameter water main that will provide interconnection to existing waterlines on Serenity Lane to Sherbrook Drive, passing through the Colby Park wooded areas and the installation of new gate valves on East 290<sup>th</sup> Street, Rockefeller Road and Bishop Road.

City of Willoughby: Installation of approximately 1,160 LF of 12-inch diameter DIP and 16-inch HDPE water main on Chagrin River Road that will connect to existing waterlines at Ridge Road to the north and to an existing waterline that terminates at a hydrant just south of the Gullybrook Park entrance drive to the south.

City of Willoughby Hills: Removal of an existing pressure reducing vault (PRV) Eddy Road, removal of an existing PRV vault on River Road and the installation of a new PRV vault on River Road between Eddy Road and Eagle Road.

All work under this contract shall be completed within **120 days** of Notice to Proceed.

Said improvements shall be in accordance with specifications and on forms on file with the Lake County Department of Utilities, 3<sup>rd</sup> Floor, 105 Main Street, Painesville, Ohio 44077. The bid package may be obtained from CT Consultants, Inc., 8150 Sterling Court, Mentor, Ohio 44060 (440-951-9000) at a non-refundable cost of One Hundred Twenty-Five Dollars (\$125.00) picked up or One Hundred Fifty Dollars (\$150.00) mailed.

Bids shall be addressed to the Board of Lake County Commissioners, Lake County Administration Center, 105 Main Street, 4<sup>th</sup> Floor, Painesville, Ohio 44077, attention Jennifer Bell and marked **Maple Grove and Rockefeller I-90 Crossing Improvements – Project No. 363-W – 2018**.

Inquiries must be submitted in writing to Consulting Engineer, **Jerry Smith, CT Consultants, Inc., 8150 Sterling Court, Mentor, Ohio 44060** at [CT170498@ctconsultants.com](mailto:CT170498@ctconsultants.com). **Questions asked within 72 hours of the bid opening cannot be answered.**

Pursuant to R.C. 153.01 et. seq., the bid must be accompanied by an original sealed document in the form of a bond for the full amount (100%) of the bid, **OR** by a certified check, cashier's check, or irrevocable letter of credit equal to ten percent (10%) of the amount bid, drawn on a solvent bank located in Lake County and payable to the Treasurer of Lake County, Ohio, as surety that if the bid is accepted, a contract will be entered into and its performance properly secured. Should any bid be rejected said surety shall forthwith be returned to the bidder and should any bid be accepted such bid bond, certified check, cashier's check, or letter of credit will be returned to the bidder upon proper execution and securing of the contract.

No bidder shall be considered lowest and best or eligible to be awarded the contract to which this Notice or Bid Specifications apply, if the bidder is listed on the Auditor of State's Database as having a "Finding of Recovery" as that term is defined in R.C. 9.24.

Bids shall be subject to the conditions that the right is reserved to hold bids for a period not longer than sixty (60) days after date of bid opening and/or to award the contract at any time during said period.

The successful bidder will be required to execute the contract within ten (10) days after the award of the work to him/her, and he/she shall furnish acceptable bond or surety, if not filed previously to the satisfaction of the County of Lake, Ohio for the faithful performance of said contract in the sum of one hundred percent (100%) of the total amount of the bid. In case of failure to execute the contract as stated or to furnish bond and/or surety, the bidder shall be considered to have abandoned the contract and is then liable for the difference between his/her bid and the next lowest bid, not to exceed ten percent (10%) of the amount bid.

The County reserves the right to reject any or all bids, to increase or decrease or omit any item or items, to waive any and all informalities, and to disregard all nonconforming, nonresponsive or conditional bids. ORC 153.011 may apply. Each bid must contain the full name of every party or all parties submitting the proposal. Each bidder must submit evidence of its experience on projects of similar size and complexity. All contractors and subcontractors shall comply with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972 and Governor's Executive Order 84-9. The contract shall be awarded to the lowest and best bidder.

Wage Rates – Each employee employed by the contractor or any subcontractor and engaged in work on the project under this contract shall be paid prevailing wage rates for Public Improvements as provided by the appropriate Sections of the Ohio Revised Code. For further information, contact OBES Wage and Hour Division (614) 644-2239 or contact the Lake County Prevailing Wage Coordinator (440) 350-2770. This shall occur regardless of any contractual relationship which may be said to exist between the contractor or any subcontractor and such employee.
