- \*\* Precinct officials may not discuss candidates or issues, or display any campaign materials.
- \*\* People may distribute campaign literature and conduct exit polls as long as they stand outside the limits of two small flags placed outside the entrance of the polling place.
- \*\* If there are any questions or problems, call the Lake County Board of Elections immediately! 440-350-2700
- \*\* The Polls are open from 6:30 A.M. until 7:30 P.M.
- \*\* Absentee Ballots **may not** be dropped off at the polling location.
- \*\* If a person has requested an Absentee Ballot, they must vote that Ballot, regardless of whether or not circumstances change the reason for the Absentee request.
- \*\* Polling locations have been consolidated. There is one sign-in in the building for all precincts in the building.
