Order of questions/issues: state; municipal; township; school and other districts; and county

Issue #

- 1 Eastlake City (12 pcts.)**
Charter Amendment – Shall Section 3 of Article V of the Charter of the City of Eastlake be amended to replace the existing Section 3 of Article V to allow removal of a council member for absence for three consecutive regular meetings of Council or five (5) total regular meetings of Council?
- 2 Eastlake City Ward 1 Precinct B**
Shall the sale of beer, wine and mixed beverages and spirituous liquor be permitted for sale on Sunday by Crolrish Burgers Eastlake LLC, DBA Crowleys, an applicant for a D-6 liquor permit, who is engaged in the business of bar/restaurant at 35647 Vine St. Eastlake, OH 44095 in this precinct?
- 1 Painesville City Ward 2 Precinct A (On Premise)**
Shall the sale of intoxicating liquor, of the same types as may be legally sold in this precinct on other days of the week, be permitted in this Painesville City Ward 2 Precinct A for consumption on the premises where sold on Sunday?
- 2 Painesville City Ward 2 Precinct A (Off Premise)**
Shall the sale of wine and mixed beverages, of the same types as may be legally sold in this precinct on other days of the week, be permitted in this Painesville City Ward 2 Precinct A for consumption off the premises where sold, on Sunday?
- 1 Timberlake Village (1 pct.)**
3.6 Mills Renewal Levy – current expenses – collecting \$55,000 annually – amounting to \$83 for each \$100,000 – 5 years – commencing in 2024, first due in 2025.
- 2 Timberlake Village (1 pct.)**
4.6 Mills Renewal Levy – current expenses – collecting \$70,000 annually – amounting to \$105 for each \$100,000 – 5 years – commencing in 2024, first due in 2025.
- 3 Timberlake Village (1 pct.)**
5.8 Mills Renewal Levy – current expenses – collecting \$59,000 annually – amounting to \$88 for each \$100,000 – 5 years – commencing in 2024, first due in 2025.
- 1 Leroy Township (2 pcts.)**
1.5 Mills Renewal Levy - improvement, construction, reconstruction, resurfacing and repair of roads – collecting \$158,000 annually – amounting to \$37 for each \$100,000 – 5 years – commencing in 2024, first due in 2025.

- 1 Kirtland Local School District (7 pcts. + portion of Geauga)**
3.44 Mills Renewal Levy – emergency requirements – in the sum of \$1,450,000 – amounting to \$120 for each \$100,000 – 10 years – commencing in 2024, first due in 2025.

- 1 Madison Local School District (12 pcts. + portion of Geauga)**
1.5 Mills Renewal Levy – emergency requirements – in the sum of \$697,270 – amounting to \$46 for each \$100,000 – 5 years – commencing in 2024, first due in 2025.
