CALL TO ORDER: Commissioner Hamercheck called the Meeting to order at 10:05 a.m., Thursday, April 15, 2021.

ROLL CALL: Upon roll being called, Commissioners Young, Plecnik and Hamercheck were present.

APPROVAL OF MINUTES:

Upon a motion by Commissioner Plecnik, seconded by Commissioner Young, the minutes of the Regular Meetings of March 18, 2021, March 23, 2021, and March 25, 2021 were approved as follows: "AYES": Commissioners: Young, Plecnik and Hamercheck "NAYS": None.

<u>OPEN TO THE PUBLIC</u>: Commissioner Hamercheck asked if anyone in the audience wished to address the Board. No one present wished to address the Board at this time.

This contract will provide the maintenance to all of the sites for the year. DEPARTMENTAL REPORTS:

<u>UTILITIES</u> – Mr. Rothlisberger reported that they had thought there may be some cost and availability issues with plastic piping due to the weather in Texas but they were happy to receive bids that were more in line with pricing from 2019-2020. Commissioner Hamercheck asked how many water main breaks they had to repair this winter. Mr. Rothlisberger replied that they had an average year but he did not have an exact number.

JOB AND FAMILY SERVICES - none.

COUNTY ADMINISTRATOR – Mr. Boyd gave an update on the Covid-19 vaccine program, stating that the efforts by the Health District, Lake Health and the Fire Chiefs and Lake County in totality is starting to show in the numbers in the State. At this time, Lake County continues to rank first with the highest number of first-time vaccinations of the counties with a population of 225,000 or more. Lake County ranks second with counties of populations of 50,000 or more. Mr. Boyd reported that Lake County has moved up to third for the entire State of Ohio. He continued to report that the 1st dose percentage for the State is 35.99% and that Lake County is at 41.37% with no doses wasted; we are at approximately 75% herd immunity. Mr. Boyd reported on the Mega-PODs stating that the demand for the larger PODs seems to be diminishing not only in Lake County but throughout the State. The Health District will begin their migration process and move toward on-site vaccinations (businesses and schools, etc.). Mr. Boyd read the following statement from Health Commissioner Ron Graham:

Please share with all that have been helping fight the pandemic beside us hand in hand....there are far too many heroes but we want to thank as many of them as possible! The last twelve months have affected the lives of people around the world, Ohio, and of course Lake County. The pandemic has changed our lives overnight. We scrambled to adapt a new norm for work, school, and public events. We worked through the challenges of social distancing, telecommuting and modified work routines, and participated in hundreds of video conferences through this collective experience. On a positive note, all of us are discovering new partnerships, strengths, and innovative work practices. Important community values are shining through in beautiful ways. For many, technology is helping break the isolation and there is a newfound trust among our employee; a new comfortable level among each other.

Today, I would like to acknowledge the strength in our teams and our coordination/communication. Everyone has been working tirelessly, harnessing all their energy and skills to meet the needs of our customers and partners. They do whatever it takes to get the job done. For that, I want to thank all partnering employers and employees who have adjusted their way of working to support our vaccination, mass vaccination, and travel clinics. I am proud of the work values, spirit, and unity I have observed in our partners and residents across Lake County, as we push to return to normalcy. To our vaccinators, our leadership, and partners, we know how extraordinary these times are for you and your families. We believe solidarity will help us get through this together. We will continue to provide you the utmost support and services. In these moments of uncertainty, there is one thing you can always count on—our commitment to you and our success. We are extremely honored to serve and partner with you today and in the future. Together we are stronger!
