CALL TO ORDER: Commissioner Hamercheck called the Meeting to order at 10:10 a.m., Thursday, June 3, 2021.

ROLL CALL: Upon roll being called, Commissioners Plecnik, Young and Hamercheck were present.

JOB AND FAMILY SERVICES - none.

<u>COUNTY ADMINISTRATOR</u> –Mr. Boyd welcomed Ms. Suzanne Casar to her first meeting in her new capacity as Director of Job and Family Services. He gave an update on Covid-19, stating that Lake County continues to be one of the top 2 counties in the State for vaccinations with Delaware County being the other. He stated that currently 53% of Lake County residents have been vaccinated. Mr. Boyd thanked the Buildings and Grounds staff for their excellent work in spring clean up and the addition of flowers to the gardens on County grounds.

The Board discussed several options for public comment with Mr. Boyd and Mr. Hackman but will discuss them again further at a later date.
