## LAKE COUNTY BOARD OF COMMISSIONERS AND LAKE COUNTY GENERAL HEALTH DISTRICT PARTNER ON MOBILE MEDICAL CLINICS

The Board of Lake County Commissioners has partnered with the Lake County General Health District to purchase a mobile medical unit for use throughout Lake County. The mobile medical unit will be used to help bring the COVID-19 vaccine to all areas of Lake County and ensure that all Lake County citizens have the opportunity to receive the COVID-19 vaccination. The mobile medical unit is accessible for individuals with physical disabilities, and will allow the Lake County General Health District to better serve the whole community, including persons with disabilities and persons who are homebound.

"The procurement of the mobile medical unit is another example of the partnerships between the Board of Lake County Commissioners and other Lake County governmental entities. Through continued partnerships, throughout the county, the Board of Lake County Commissioners are able to provide Lake County citizens the best services possible," said Lake County Commissioner President John Hamercheck.

"The work of our County Health District, first responders and health care professionals have helped Lake County exceed both state and national levels in healthcare. Today's announcement of a mobile medical unit bolsters our commitment to public health in Lake County and will ensure a higher level of service for our seniors and any resident for whom personal travel is a challenge," noted Lake County Commissioner John Plecnik.

"I am proud to support the work of the Health District and their commitment to providing vaccine opportunities to all County residents who wish to receive one. This investment will allow our team to take the vaccine to all of those desiring this service.
