CALL TO ORDER: Commissioner Hamercheck called the Meeting to order at 10:03 a.m., Tuesday, November 23, 2021.

As soon as we are finished gathering and verifying the appropriate materials, I'll share the information with the residents of Lake County and any elected official or agency interested and the news media."

Ms. Lois Osborn of 334 S. St. Clair Street in Painesville voiced her opinion and concerns about the recent news being distributed by the media.

Ms. Olivia Mitchell, a reporter from Cleveland.com, asked for details regarding a security badge.
