I would like to continue as the Lake County Bee Inspector in 2018.

Last year was a busy one for me as, once again, there were many new beekeepers. I helped them through the difficulties that most "Newbees" experience, along with 2 beekeepers who apparently bought packages of bees that were Africanized. This creates a whole new problem for us as they are too aggressive to handle and dangerous to people and pets. They were destroyed and a letter was sent to the supplier alerting him to the fact that it is HIS responsibility to acquire packages from reputable suppliers. We still have the mite problem to address, and they kill around 60-70% of our bees each year. I try to set treatment programs that will increase our beekeeper's chances of success. There are new studies that recommend alternative treatment methods to control mites, and there are breeders who are trying to develop bees that are more resistant to mites. Research is ongoing, and we all have hope that there will be an equilibrium reached between the parasites and their hosts, but probably not soon.

Thank you for your continued support for the Apiary Inspection Program that is so necessary to our community. Healthy bees are so important for a healthy environment, and work must be done to protect them...when so many things are harming them. I work to foster good beekeeping habits, and to find solutions to our present problems...so we can continue to enjoy the fruits of their labors. Thank you.

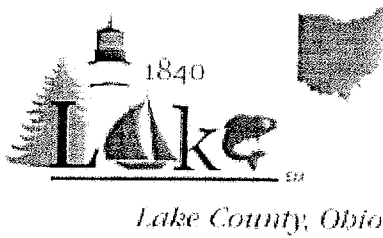
"Yes, I would like to continue my work as the Lake County Apiary Inspector in 2016. The past few years has found fewer beekeepers with large numbers of hives, and more new beekeepers with one or two hives. This year, there were lots hives that lost their queens, or never had a mated queen. Poor queens is a new problem that we all deal with. I spend most of my time helping new beekeepers keep their hives alive.
