Mr. Marty Gareau, from the Lake County Ohio Port and Economic Development Authority, explained that Ericson Manufacturing is in the middle of continued expansion of their business in Willoughby. The application is for \$100,000 and the company received \$50,000 from the Port Authority and the other half from a bank. The money will be used for computers and tooling for a new project.

Mr. Jay Ericson, CEO of Ericson Manufacturing, stated that they are developing molds and expanding and they are creating more jobs.

Commissioner Troy stated that Ericson Manufacturing has been in business for a long time, and helping them invest in their operations and adding jobs is certainly a good use of community development funds. The Commissioners appreciate their commitment to Lake County.

Mr. Gareau stated that the County has worked with them before and they have been timely with their repayments and job creation requirements. Ericson was one of the companies that initially contributed to getting the Economic Development Center up and running and they have kept their business in Lake County and are

Commissioner Moran congratulated Mr. Ericson and thanked him for keeping the business in Lake County. Ms. Rhea Benton, CDBG Coordinator, stated that part of her job is to keep an eye on job creation and the Ericson has created four full time jobs and exceeded the two-job creation requirement. She is excited to work with them

Commissioner Troy stated that it is a worthwhile program and it has worked and established great public and private partnerships with manufacturing companies.
