CALL TO ORDER: Commissioner Hamercheck called the Meeting to order at 10:35 a.m. Thursday, January 13, 2022.

<u>COUNTY ADMINISTRATOR</u> –Mr. Boyd referred to item #9 on the agenda that pertains to the contract negotiations with McDonald Hopkins. He stated that Budget Director Matas, Assistant Prosecutor Hackman and himself recommends them to offer legal and technical support to ensure the County remains in compliance with the ARPA funds. He also stated that he is in the process of reviewing the 400+ page ARPA final guidance report. The Board agreed that the County must be cautious in spending.

FINANCE – none.

<u>CLERK</u> – Commissioners Clerk, Ms. Jennifer Bell, stated that the next Commissioners Meeting will be held on Thursday, January 20, 2022 at 10:00 a.m. She also stated that County Offices will be closed Monday, January 17, 2022 in observance of Martin Luther King Day.

OLD BUSINESS: - none.

<u>NEW BUSINESS</u>: - Commissioner Plecnik referred to the recent News Herald 2021 Lake County's year in review article that highlighted several items including the COPS Program, the Utilities Senior Discount Program, the historical attendance record set at the Lake County Fair and the census.

Commissioner Hamercheck thanked the Building and Grounds Department and all those involved in preparing for the recent Code Blue. He stated that the warming centers/shelters were very prepared and that they were run seamlessly.

<u>PUBLIC COMMENT</u>: Commissioner Hamercheck asked if anyone in the audience wished to address the Board. Mr. Brian Massie of 8196 Rainbow Drive in Painesville asked if there were statistics available for the Senior Water/Sewer Discount Program. He spoke of a discrepancy in unencumbered funds and gave an update on the unclaimed funds from property taxes. In addition, he spoke of the ARPA funds the County will be receiving and suggested that the Treasurer be permitted to add an employee to focus on the outstanding unclaimed funds that should be returned. Commissioner Hamercheck stressed that there are no mathematical errors with the unencumbered fund discrepancies. He stated that the County will be receiving a total of \$44.7 million in ARPA funds that will be spread out equally over this year and 2023. Commissioner Plecnik gave a detailed explanation and several examples of unencumbered funds.

Mr. John Muzik of 45 Coventry Drive in Painesville Township asked how many seniors may be eligible for the Senior Water/Sewer Discount Program. Sanitary Engineer, Mr. Randy Rothlisberger, explained that there are approximately

10,000 eligible seniors but this number includes some seniors being counted twice as they qualify for both the water and the sewer. He explained the number may be closer to 6,000.
