DEPARTMENTAL REPORTS:

<u>UTILITIES</u> - Commissioner Troy asked for an update on waterline breaks.

Mr. Randy Rothlisberger, Assistant Sanitary Engineer, reported that they are averaging one break a day as the cold temperatures continue. He explained that last year the average was two breaks a day through January and February. There have been 8 breaks in February.

<u>JOB AND FAMILY SERVICES</u> - Mr. Matt Battiato, Director of the Lake County Job and Family Services Department, reported on Medicaid Redetermination and thanked *News-Herald* reporter Mr. John Hutchison for his article regarding the changes in Medicaid redetermination. He stated that the State recently sent out letters notifying recipients that they have until February 28, 2015 to complete and return their application. The media has been getting the word out across the State. Once the deadline is passed he will report on the numbers. Commissioner Troy asked if there were people available to assist with completing the Medicaid redetermination forms?

Mr. Battiato reported that the Lake County Council on Aging and JFS are available to help and there are Benefit Banks throughout the County that will also help people fill out the application.

COUNTY ADMINISTRATOR - none

FINANCE - Mr. Joel DiMare, Budget Director, reported that the General Fund and Outside General Fund budgets will be on the agenda for the February 19, 2015 Commissioners Meeting at 2:00 p.m.

CLERK - Ms. Amy Elszasz reported that Lake County Offices will be closed for Washington-Lincoln Day on Monday, February 16, 2015.

LEGAL - none

OLD BUSINESS: - none

NEW BUSINESS: - Commissioner Malecek reported that he just returned from CCAO's New Member Training Seminar where there were 45 newly appointed and elected Commissioners around the State. This is the biggest turnover on record.

<u>PUBLIC COMMENT</u>: Commissioner Troy asked if anyone in the audience wished to address the Board? Ms. Becky Lynch, 8040 King Memorial Drive in Mentor, Ohio, also thanked Mr. John Hutchison, the News-Herald reporter for his article about the number of Lake County residents who will be affected by the Medicaid redetermination process. She stated that approximately 110,000 Lake County residents will be affected, according to the last Commissioner's Meeting, and wanted to know how that was possible.

Ms. Lynch then asked about Resolutions 7 and 8 relating to the Federal Equitable Sharing Agreements with the United States Department of Justice and the United States Department of the Treasury.

Mr. Eric Condon, Legal Counsel representative of the Prosecuting Attorney's Office, stated that these are typically joint projects between federal agencies and local sheriff's and prosecutor's offices that they are all in agreement on how to split up any forfeited property and funds.

Commissioner Troy stated that Mr. Battiatio indicated that there are approximately 110,000, impacted Medicaid recipients statewide, not 110,000 in Lake County and there are approximately 600-800 recipients in Lake County. Mr. Muzik, 45 Coventry Drive in Painesville Township, asked about the Ohio Checkbook website and asked if participating in the site gives more work for the County?

Commissioner Troy explained that the program was instituted by the Treasurer of State. The information that

is reported by counties is being published on the website and to his knowledge it is not causing any additional work for the County.

Mr. Muzik stated that he heard if any municipalities do not cooperate the Treasurer would visit those communities?

Commissioner Troy replied that there are statutes that require what is reported to the State and governmental agencies are subject to an annual audit.

The next regular Commissioners Meeting will be held on Thursday, February 19, 2015 at 10:00 a.m. followed by a second meeting to be held on the same day, Thursday, February 19, 2015 at 2:00 p.m. that will focus on the budget. Lake County offices will be closed on Monday, February 16, 2015 in observance of President's Day.
