DEPARTMENTAL REPORTS:

<u>UTILITIES</u> - Mr. Matt Armand, Public Service Coordinator for the Department of Utilities, reported on the effects of the thaw this time of year and stated that crews are out and ready to mobilize. He explained, on average, the GLK Plant processes 13.5 million gallons of water a day. Yesterday, the GLK processed 32 million gallons of water in one day. There have been no recent customer complaints.

gallons of water in one day. There have been no recent customer complaints. Commissioner Troy stated that it appears that the system is handling the water. It is supposed to rain next week but crews are ready. The GLK is located in Mentor and this thawing event will be great data for the integrated study being done on the area.

Mr. Rick Martin, Executive Director of the Department of Utilities, stated that they working with Stormwater in the Mentor area.

Mr. Randy Rothlisberger, Assistant Sanitary Engineer, reported that the frost this year is four feet deep. He stated that there are spikes in breaks during the thaw but the crews are ready.

Commissioner Troy reported that CCAO is monitoring the State Budget Process. There was a recent meeting with the CCAO Taxation Committee and one item that is being endorsed is the proposal of dedicated funding for local airport funding. Presently, fuel that is sold at regional airports is subject to the sales tax and not the fuel tax. This generates about \$16 million a year to the state general fund and through ODOT about \$1 million is appropriated. The proposal is to add an 18 cents excise tax to a dedicated fund for access only by local airports. This is an item of interest since the Port Authority owns the Lost Nation Airport.

Commissioner Troy reported on a proposed OPWC law change. Presently, 20% of SCIP money has to go into the loan fund and there are excessive balances in the fund. It used to be an 80/20 split and the proposal is to change it to a 90/10 split to free up funding for grants to generate more money for local projects. Another concern is the indigent defense fund. Originally when it was made a state mandate, the cost was 50/50 between the State and the County, however over the years the reimbursement level from the State has been more like 25% to 30%. This affects the local public defender's budget. CCAO would like to see an additional \$12 million a year placed into the budget to bring this back to a 50/50 shared cost.

Commissioner Troy stated that there is feeling among legislators that the Governor's budget and tax proposals will be markedly different after going through the House. There are some concerns about the replacement fund for tangible taxes. It could result in a half million dollar loss for our Deepwood programs so that these dollars can be shifted to give individual income tax cuts.

Commissioner Moran asked County Engineer Gills about the bumps that have showed up on S.R. 2 after the thaw. Mr. Gills reported that there is a decent-size bump just to the east of S.R. 44 going west. There are some smaller bumps on the other side of the highway but not as large as this one and it is a serious condition. A bright circle has been painted around it to warn motorists and a sign has been posted before the bump. They are looking to acquire a flashing sign as well. It appears as though traffic is moving around it. Two of these lanes where the bump is located will be closed St. Patrick's Day for safety reasons.

Commissioner Troy asked if the cause could be a chemical reaction between the soil and concrete?

Mr. Gills explained that there will be testing for sulfates. A hole will be drilled and a sample will be taken in order to determine the appropriate repair. The repair will probably be involved and will be handled by ODOT.

Mr. Gills then reported that the contractor will be proceeding with the bridge the first of the week. The Commissioners will be seeing the contract soon.
