OPEN TO THE PUBLIC:

Commissioner Troy stated that without any objection he would like to read the OSU Extension resolution celebrating the 100th Anniversary of the Smith-Lever Act and the establishment of the Nationwide Cooperative Extension Service. Commissioner Troy welcomed staff from the OSU Extension Office who were in attendance to celebrate the 100th Anniversary. He read the resolution, which was presented to Mr. Randy Zondag, Extension Director and Educator, Horticulture/Natural Resources. The Lake County OSU Extension staff is recognized additionally for providing programming to residents and students on a variety of topics including nutrition, recycling, parenting skills, financial management and budgeting and coordinates with the Juvenile Court and the Department of Job and Family Services to extend programs that ensure positive outcomes for individual clients and their families. Lake County enjoys a vibrant 4-H program that actively contributes to the community and is endowed with fertile agricultural resources that has drawn global renown for the commercial horticulture expert who travels the world to share the virtues and methodologies of the local industry as well as to glean pioneering concepts for introduction into Lake County. Also in attendance was Mr. Frank Lichtkoppler, Extension Specialist, Sea Grant, and Ms. Lisa Siciliano-Miler, Extension Educator, Family and Consumer Sciences. Mr. Zondag thanked the Commissioners for their support and stated that this is one of the best counties they

<u>UTILITIES</u> - Mr. Matt Armand, Public Service Coordinator for the Lake County Department of Utilities, reported that the next special collection is for tires on Saturday, May 10, 2014 from 8:00 a.m. to 1:00 p.m. at the Lake County Fairgrounds. People can bring up to six tires without rims for free. Tires with rims will cost \$4.00 per tire, oversize tires cost \$10.00 per tire and if there are over six tires, the cost is \$2.00 for each additional tire. These special collection dates prevent hazardous materials from ending up in a landfill. Commissioner Aufuldish reported that he is the Lake County representative for LEEDCO and he recently heard that, unfortunately, the Ice Breaker Project on Lake Erie was not chosen to receive a \$47 million grant from the Department of Energy. At the next LEEDCO meeting they will decide what will be the next direction.

Commissioner Troy reported that State Issue 1 passed by a 65% to 35% vote. This program will continue to be helpful to local communities and to the Utilities Department. He reported that the voter turnout in Lake County for this past election was an embarrassment for democracy with 18%, even with absentee voting available. We spend a lot more on the administration of elections and less and less people are showing up to vote. He hopes that this changes and citizens realize the importance of elections.

Commissioner Moran stated that she was a rover for the Board of Elections and at some polling places by 9:00 a.m., there were one to three voters and it was very disheartening. People have been working since March to prepare for the election. Citizens should want to have a say in how their City or County is run. If people do not like the candidates, then vote on the money issues.

PUBLIC COMMENT: Commissioner Troy asked if anyone in the audience wished to address the Board.

Ms. Becky Lynch, Mentor, stated that she agrees with the Commissioners about elections because it is everyone's freedom to cast a vote. We must get the word out on what happens here so that people know that their vote matters. It is their chance to make a difference. She also worked the polls during elections and was dismayed at the low voter turnout. It is a very long day but the people who voted were happy to vote.
